- Mission: To Protect the American people and uphold the Constitution of the United States
- Priorities
  - Protect US from terrorist attack -- abroad and homegrown
  - Protect US against foreign intelligence and espionage
  - Protect US against cybercrimes and cyber attacks
  - Combat public corruption at all levels
  - Protect Civil Rights
  - Combat criminal enterprises
  - Combat major white-collar crime
  - Combat significant violent crime
  - o Priorities tie into forensic accounting
  - All priorities have money trail
  - Money changes hands = Money trail
  - Background of agents is vast
  - Likened it to a puzzle
- Support squads

  - Neutralize Threat
- What is Forensic Accounting
  - The <u>SCIENCE</u> of investigating <u>PEOPLE</u> and <u>MONEY</u>
- Overview of duties
  - Identify financial accounts
  - Accompany SAs on interviews

- Provide financial details for affidavits and warrants
- Extra insight and filler of details
- Brief Assistant U.S. Attorneys, Special Agents, and others on findings
- Prepare analysis and exhibits for indictments and trials
- Testify in Grand Jury or trial
  - Not SA, but Forensic Accountant
- Look for
  - Evidence of allegation
  - Assets for forfeiture
  - Subjects living beyond their means
  - Indicators of money
  - Fraud scheme
    - What we look at:
      - Victim's money into subject's bank account
      - Expenditure of money from sobject's accounts
      - Assets for forfeiture
    - What you look at
      - Social media
      - DMV, vehicle records, property records
    - How victim/company money was used
- Working together
  - Drug trafficking/money laundering
    - What we look at:
      - Flow of money in bank account

  - How to move forward into special agent position
    - Forensic Accounting lends well to special agent
    - Spend several years in private industry

- Resume -- Federal Resume Format
  - 2-3 pages at the least if fresh out of college
  - 3-4 pages at the least if experienced
- No acceptance if not in Federal Resume Format
- Sell what you bring to the table
- Get and maintain a Top Secret Clearance

  - Put as much as you need on your resume
  - o Can we put you in a gang squad/counterintelligence squad
  - Soft skills are needed
  - Gaps in resume = Concern
  - Trust is key
- Travel Frequency (Claire Wu)
  - Depends on squad
  - Depends on needs of bureau/squad
  - If you don't want to travel
  - Cyber guys travel a lot
  - Gang squad doesn't travel a lot
  - Needed training is paid for
  - o Raise your hand for travel you are doing
- How many hours do you work (Nairf Aldhafairi)
  - With few exceptions, banker's hours
- How dangerous is this job as a forensic accountant (Andrew Forsythe)
  - Proactive organization
  - Long-term, behind-the-scenes
  - Not going to expose forensic accountant to safety risks
  - Danger level comparable to private accountant
- FBI is rule followers of agency
- Things are private = No access without legal grounds
- Google Search is extent of background checks in regards to social media
- No busy season
- Extra time goes into trial prep
- Banker's hours
- Plan for vacation
- Very little news release
- Behind-the-scenes
- Rewarding
- Work is slower than in private industry
- Can't really
