Interview Tips

- Have someone review your resume
 - Keep things relevant
 - List experiences/qualifications in order
- Research firm and a few things about it that interest you
 - Come with specific, genuine questions
 - Keep it current, especially your responses!
- Take advantage of the interview as an opportunity to tell your story
 - Why is it that you really want to be at EY?
 - Practice articulating why you want to work there and what interest you about the position
 - Watch your time; the longest is not always the greatest
 - o Biggest mistake: not asking questions
- Behavioral Interview Questions:
 - Based on past behaviors, not hypothetical situations

- Have stories in the back of your mind that you went through recently that you can talk about
- o STAR Approach:
 - Situation
 - Task
 - Action
 - Result
- o Performance deal breakers
 - Have no questions
 - Uneducated on firm/position
 - Seem desperate, arrogant, disinterested
 - Chew gum
 - Etc
